#### Masahiro Kawai

Dr Masahiro Kawai joined ADBI as Dean in January 2007. He taught economics at the Johns Hopkins University as an assistant and an associate professor (in 1978-86) and at the University of Tokyo as an associate and full professor (in 1986-2008). He graduated with his B.A. and M.A. degrees in 1971 and 1973, respectively, in Economics from the University of Tokyo's Faculty of Economics. He earned a Ph.D. degree in Economics from Stanford University in 1978. His field of interests are International Finance and Open Macroeconomics, Asian Economy and Finance, International Development Finance.

# Ming Lu

Dr. Ming Lu is Professor of Economics and Director of Fudan Institute for Industrial Development at Fudan University, China. He is also research fellow of Employment & Social Security Research Center (ESSRC), and China Center for Economic Studies (CCES), Fudan University. He has consulted for the World Bank. He has a Ph.D. in Economics from Fudan University. He has published his papers on Journal of Comparative Economics, Review of Income and Wealth, and top Chinese economics journals. His recent research covers Labor Economics (income distribution, and migration), Development Economics (urbanization, and regional development) and Social Economics (social network, trust and economic development)

#### Bui Xuan Du

Mr. Bui Xuan Du is researcher currently working for the Institute of Labour Science and Social Affairs (ILSSA) under the Ministry of Labour, Invalids and Social Affairs (MOLISA) of Vietnam. Since 2005, he has been heading the division of social security policies studies. He was a team leader of the social protection department (2001-2003) and ministerial leader's assistant (2003-2005). Mr. Du received a master degree in business administration from National Economic University in 2004.

### Shinji Asanuma

Dr. Shinji Asanuma is currently Visiting Professor of Asian Public Policy Program, School of International and Public Policy, Hitotsubashi University, of which he was Director and Professor from 2000 through 2006. Concurrently, he is Visiting Senior Advisor to Japan International Cooperation Agency (JICA). He served as Director of Planning and Budgeting of the World Bank in 1984-87 and, subsequently, as Country Director, Asia I Department in 1987-91, responsible for a number of South-Asian countries.

He was also an investment banker with Kuhn Loeb & Co. (which later became Lehman Brothers) from 1973 through 1984, working as its Far East Representative in Tokyo, and, he was a director and the head of its Tokyo Office, of S.G. Warburg (currently UBS Securities) from 1991 through 1996.

In these varied capacities, he worked for and with the government of Asian countries for over forty years, either as a World Bank official or as international financial advisor.

# Kanit Sangsubhan

Dr. Kanit Sangsubhan received a Ph.D. in Economics from Department of Economics. University of Toronto, after graduated Bachelor and Master of Economics from Department of Economics, Thammasat University, Bangkok. Dr. Sangsubhan has served as the Director of the Overall Planning Division at the National Economic and Social Development Board (NESDB) in Thailand during 1996-1999. He also served as an Advisory Staff to Deputy Prime Minister and Minister of Commerce, Dr. Supachai Panitchpakdi during 1994-1996 and as an expert to the Standing Committee on Economics of the House of Representatives, Parliament of Thailand during 1996-1997. He later joined the Asian Development Bank Institute, Tokyo as a visiting scholar during 1999-2000. In December 2000, Dr. Sangsubhan has joined the Fiscal Policy Research Institute as the Director of the institution. He was a member of Advisory Board for Asian Development Bank Institution in 2007, and a member of board of the TISCO Bank Ltd in 2006-2008. Also, he has served as a Director of Dhanarak Asset Development Board since 2004. Lately, he was assigned to be an Honorable Economic Advisor to Prime Minister in 2008.

# Yonghyup Oh

Dr. Yonghyup Oh is director of the Department of International Macroeconomics and Finance at the Korea Institute for International Economic Policy (KIEP). He is co-editor of Asian Economic Papers journal. He worked for Korea Investment Trust, Korea Long Term Credit Bank for several years and for Seoul Metropolitan Government before joining KIEP. He has been advisor and consultant to Korea Ministry of Finance and Economy, Korea Ministry of Foreign Trade, Parliament of Korea, Korea International Trade Association, Seoul Metropolitan Government, and private sector organisations such as Korea Asset Management Corporation. He was researcher at the Centre for Economic Performance at the London School of Economics and at the economic research centre DELTA in Paris.
